INFORMATION LETTER

Dear colleagues!

On October 20-22, 2022, the Dostoevsky Omsk State University holds an International Scientific Conference "Federal State: Historical and Legal Experience and Modern Practices (on the occasion of the 100th anniversary of the formation of the USSR)".

The conference is supported by the History of the Fatherland Foundation.

The purpose of the conference is to examine and evaluate the historical and legal experience of the Soviet federal state, transit of legal forms into the legislation of Russia and other states in the post-Soviet space, their transformation in the context of international and interstate interaction.

We invite to participate in the conference scientists and specialists who research problems of federal relations.

The conference will be held in the format of a **plenary session** and the following **sections**:

1. *Soviet Federation: historical origins and stages of development.*
2. *Federalism and federation: theoretical and practical perspectives.*
3. *Integration and interaction in the modern legal space.*

Conference format: on-site participation and virtual participation.

The completed application (the form is given in *Appendix 1*) should be accompanied by the abstracts of the report (the requirements for the abstracts are given in *Appendix 2*) for the publication of the collection of conference materials.

The Organizing Committee reserves the right to select applications taking into account the relevance of the content of the abstracts to the topic of the conference.

The publication of a collection of abstracts of reports in printed and electronic form is planned for the beginning of the conference. All published materials will be indexed in the RSCI and placed in the scientific electronic library www.elibrary.ru.

The guests of the conference are invited to participate in a cultural program prepared for them.

ABSTRACT REQUIREMENTS

When preparing abstracts, please adhere to the following requirements.

Abstracts must have the following data:

1. UDC classification Index (UDC).
2. Title of the article.
3. Full name of the author(s).
4. Place of work (study) of each author (for example, Dostoevsky Omsk State University), city and country. When writing the names of organizations in English, all significant words (except for articles and prepositions) must begin with a capital letter.
5. Abstract (the heading "Abstract" is not needed).
6. At least 5 keywords.

The volume of the text for publication is no more than 10,000 characters with spaces (corresponds to five printed A4 pages).

Format. The text must be typed in MS Word, in formats doc. or docx. using the Times New Roman font, size 14, line spacing - one and a half. Margins: left - 3 cm, right - 1.5 cm, top and bottom - 2 cm. Page numbering - in the middle of the bottom margin.

Abbreviations require mandatory decoding in the text itself (at the first mention) or in a separate list (at the end of the publication).

The list of references should be placed at the end of the article; sources are indicated in the order of their mention in the text (not alphabetically).

References to sources from the list of references should be in-text: the serial number and pages of the cited source are indicated in square brackets, for example: [4, p. 32–35] or [4, p. 30; 5, p. 78–79].

When compiling a list of references, it is recommended to use the following example.

Requirements for the design of the list of references

The list of references is given at the end of the article. The sources in the list are given in the order they are mentioned in the text, indicating the total volume of the publication (see the sample above) or the pages of a specific work (if it is an article).

Electronic source references should follow the example:

Author. Title // Name of website: [website]. – Year of publication. – Date of publication. – URL: https://www.****.***.html (accessed 09.02.2018).

In case of repeated mention of the publication in the text of the article, it is necessary to indicate its serial number from the List of references and pages in square brackets. Several works cannot be placed under one number in the list of references; they should be mentioned under independent numbers. Every mention of the author should be accompanied by the author's full name in each specific case.
